- 3 I, the undersigned understand that by participating in this show, [name of minor] may become exposed to the risk of injury, and I consent to the participation.
- 4 I, the undersigned assert that the above named minor voluntarily consents to participation in this show.
- 5 I, the undersigned acknowledge the risk referred to above and agree to waive any and all rights that I, the above named minor or any other person, may have against the Benalla Agricultural & Pastoral Society Inc in relation to any loss or injury (including death) that is suffered by the above named minor as a result of participation in this show.
- 6 I, the undersigned agree to continually indemnify the Benalla Agricultural & Pastoral Society Inc on a full indemnity basis against any claim or proceeding that is made, threatened or commenced and any liability, loss (including consequential loss and loss of profits), damages or expense (including legal costs on a full indemnity basis) that the Benalla Agricultural & Pastoral Society Inc incurs or suffers, as a direct or indirect result of the above named minor's participation in any event held by the Benalla Agricultural & Pastoral Society Inc.

WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012

Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named on this form is required to ensure that the recreational services it supplies to you-

- Are rendered with due care and skill; and
- Are reasonably fit for any purpose which you, either expressly or by implication, make known to the supplier; and
- Might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22 of the *Australian Consumer Law and Fair Trading Act 2012*, the supplier is entitled to ask you to agree that these statutory guarantees do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the *Australian Consumer Law and Fair Trading Act 2012* if you are killed or injured because the services provided were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. **Gross negligence**, in relation to any act or omission, means doing the act or omitting to do an act with reckless disregard, with or without consciousness, for the consequences of the act or omission. See regulation 5 of the *Australian Consumer Law and Fair Trading Regulations 2012* and section 22(3)(b) of the *Australian Consumer Law and Fair Trading Act 2012*.
